**How to Prepare a Short Preparation Debate 12 Steps**

October 4th, 2017 - A short preparation debate is a kind of debate where two teams are given a topic upon arrival and must prepare presentations within a time limit The debate teams usually have between 30 and 90 minutes to prepare their speeches In most cases teams are given 60 minutes to prepare Short preparation debates are similar to traditional debates in terms of strategy and delivery The key difference is that there is a time limit on preparation
